Welcome to IMPALLA

Are you looking for an advanced academic degree in international comparative social policy research? Would you like to be taught by internationally renowned professors with years of expertise in implementing and evaluating social policies? Would you like to be able to apply your theoretical knowledge to empirical analysis by using statistical methods and data handling?

If so, the Master of Science in Social Policy Analysis (IMPALLA) offered by CEPS/INSTEAD, KU Leuven and a number of associate institutions is designed for you.

The IMPALLA programme distinguishes itself through:

- an international and comparative focus
- a high-calibre staff
- an international and diverse student body

- an advisory team of assistant professors and researchers.

The programme is run with the support of CEPS/INSTEAD. Graduates receive a Master's degree from KU Leuven.

Besides its professional education, this programme is unique because of the congenial family atmosphere, the cohesion with all involved, and the care and attention given to the needs of the students.

Educational project

Our ambition is to train students to become qualified analysts in comparative social policy who:

- have mastered state-of-the-art research methodologies
- are sensitive to the determinants and dysfunctional effects of social action and public policies
- are able to apply their skills in evaluating social systems and programmes

The learning process is interactive and emphasises applied approaches to the subjects studied. Students are introduced to contemporary social and political theories that aim to explain societal change. They also learn to define and formulate research questions, problems and issues. They acquire a thorough understanding of the rationale and range of various research methods and an extensive knowledge of data sources. They develop an ability to make their own choices in dealing with social policy issues and learn to present their opinions critically and reflectively.



In the first term of the programme, students choose a Master's dissertation topic, which they carry out under supervision of our professors and assistant professors. This exercise aims at enhancing students':

- individual aptitude for analysis and synthesis
- ability to work in an international and/or multidisciplinary team
- skills in academic writing and presentation of research results

Profile

As an ideal prospective student, you have strong English language skills and a solid knowledge of statistics and research methodology. You have an interest in social policy and its development and implementation. You are motivated to address social problems and social change and have a desire to analyse these subjects more profoundly.

By the end of the programme, you will grasp both the overall socio-economic picture and the crucial social-policy issues at stake. You choose and master the appropriate methodologies needed to analyse the available databases. This culminates with the opportunity to share your research results with our team of professors and researchers.

Overview of the academic year

As an advanced Master's programme, IMPALLA is a one-year, full-time programme. Most courses are held in G.D. Luxembourg, but the programme includes a three-month stay at KU Leuven in Belgium during which students receive further teaching and training.

To me, the IMPALLA programme is excellent preparation for a PhD or an academic career. As for the schedule and the studying requirements, the IMPALLA year was exceptionally demanding. Learning how to use statistical and social-policy analysis tools for my research improved my methodological skills. Luxembourg and Leuven each provide an ideal working environment for students, with 24/7 access to computer facilities and the guidance of assistant professors.





Admission

IMPALLA is a highly selective programme. Admission is limited to 20 students per year. The closing date for applications can be found on the IMPALLA website. The application process is carried out entirely online.

Requirements

- A university degree of at least four years in social or behavioural sciences, including training in statistics, is a prerequisite for applying to the programme;
- Applicants must take the IMPALLA test on statistics and methodology;
- Non-native English speakers must provide evidence of English language proficiency by presenting a language test score (TOEFL or IELTS) of at least C1 level, according to the Common European Framework of the Council of Europe.

Scholarship

Thanks to support provided by CEPS/INSTEAD, the programme is able to provide need-based scholarships and merit grants. Scholarship requests do not affect admission decisions.

Programme

The programme begins with an intensive set of introductory courses in social sciences, statistics and methodology, followed by core lectures.

The lectures covering the theoretical aspects of the programme are spread out over two periods and are complemented by group work and individual exercises related to the subjects studied in class. Students are encouraged to attend international conferences, research seminars and expert meetings.
